### 877. Planning

## UTT/21/3511/HHF – 117 Birchanger Lane, Birchanger

Proposed conversion of garage/store to habitable space.

### 878. Travellers Site

There was a meeting in the Village Hall on 5<sup>th</sup> November, chaired by Brian Ross and Ayub Khan, to discuss the Planning Inspector's decision to allow the travellers to remain on the site in Birchanger. In attendance was Peter Holt, the new CE of Uttlesford District Council. It was made clear by Mr Holt that although he strongly wished to uphold the restrictions of the Green Belt, and was disappointed with the inspector's decision, nevertheless UDC has decided that they will not be seeking a judicial review. #### 879. Footpath 15

The footpath has now been cleared, although some of the cut-down vegetation has been left in situ. There is some concern that after heavy rain this could cause a blockage. The clerk will contact Robin Wallbank and ask that the vegetation be cleared.

### 880. Junction 8 roundabout improvements

The current plan is the same as previously in that, when the roundabout at the top of Birchanger Lane has been removed, residents will be allowed to cross the A120 in the direction of Dunmow Road. This crossing will be controlled by traffic lights.

David Sprunt of Essex Highways has offered to attend a meeting with the parish council to explain the full plan.

#### 881. Allotments and Recreation Ground

Estimates for repair to both sites have been received.

It was suggested that the allotment gate be secured with a coded padlock. The code would be given to allotment holders. This was agreed and a suitable lock will be purchased.

#### 882. Motor Cross track off Forest Hall Road

An area of land off Forest Hall Road is being used as a motor cross track normally for a period of 14 days each year. The secretary of the local residents group has advised that the track has been used many more times than this and has asked the Parish Council if it could intervene.

ADS has contacted Sarah Marshall of Enforcement at UDC. She has responded advising that there had been staffing issues within the Planning Enforcement Team. The officer who covered the area in which this site falls, left in April of this year and the vacancy was only filled in September. As such there have been delays in dealing with cases such as this. The case has now been reallocated to the new case officer, Oliver Sear, who will be attending the site to view the situation.

#### 883. Donation to Royal British Legion

A donation of £35 was agreed. AD will give details of the recipients to the parish clerk.

#### 884. UDC Local Plan – technical consultation

This has now been submitted and the parish council awaits the outcome. The next consultation is scheduled for March 2022.
