#### 1137 A120/M11 roadworks

AD has received an email from Rissa Long (RL) from the M11 Jct8 Improvement Scheme Team in which she advised that there had been "a couple of reports of increased traffic through Birchanger recently. Is this something you have noticed?"

AD replied that this is indeed the case and that Birchanger Lane is being used as a "rat run". AD asked if anything can be done about the increased traffic. RL responded that it is very limited in what can be done to deter the potential extra traffic. She is looking into the possibility of installing additional signage but that they were governed by the Traffic Signs and General Directions regulations as to what can be installed on the highway.

AD asked if there was any news on the proposed Open Day in Birchanger. A response is awaited.

There have also been a number of complaints, following completion of the pedestrian/cycle track, regarding the width of the road from the A120 junction to Duck End. The response from the M11 Jct8 Improvement Scheme Team is that having viewed the site they have concluded that there is actually an increase in width. However they have confirmed that following completion of all work they will be undertaking a Road Safety Audit which will look at this together with other factors.
