# 1075. Allotments/Recreation Ground

# 1076. Reports from County and District Councillors

## **County Councillor Ray Gooding**

Hertfordshire Council has been complaining about the use of their recycling centres by residents of other counties and North London boroughs. At present the reciprocal arrangement with Essex is still in place so nobody from Essex should be turned away from a Hertfordshire site.

He has requested a jetting to clear the water which is accumulating from debris being washed from the roads.

There is a package of work planned for Birchanger but this cannot be started until the Lane reopens.
