UTT/18/2214/HHF – The Old School, Birchanger Lane. Replace existing glazed conservatory roof with tiles and velux windows.

493. Land north of Birchanger Lane

- A planning application was submitted by the owner of the land, for equestrian use. Planning application number UTT/18/0308/FUL was allocated, and the application was approved.
- On 22nd July 2018 a number of caravans moved onto the site.
- An emergency injunction was applied for and granted on 30th July which prevented any further incursions onto or changes to the site.
- A public meeting was held on 7th August.
- On 13th August the High Court granted an injunction.

The owner has submitted a further planning application for residential use. This was declared invalid, and an amended application is expected.

494. Birchanger roundabout proposal UTT/18/1823/CLP

- A consultation meeting is to be held by Essex Highways in the Village Hall on 14th September. The parish council is hoping to have a private meeting before the consultation with Essex Highways representatives.
- There is a survey on the village website inviting residents to submit their comments on the proposal.
- MD will be sending a freedom of information request to Essex Highways requesting their statistics which justify this proposal, and what data was used to support the proposal that traffic leaving Birchanger Lane would only be able to turn left and not have the option of a dedicated signal allowing traffic to crossover to the A1250.
- On Monday 10th September the parish council will carry out a traffic survey, counting the number of vehicles leaving the village at the roundabout end of Birchanger Lane.
- The Parish Council's comments on the proposal were sent to Uttlesford Planning on 2nd August.

495. Volunteer Uttlesford – request for donation of £150.
