# Allotments

# **Recreation Ground**

- GT has made enquiries with MAG about the possibility of obtaining a grant. He is currently awaiting a response. He will be looking at other potential sources of grants.
- The roundabout is out of commission and needs complete renovation. PS has enquired with two companies, HAGS and Sovereign, but both have declined to carry out repairs.
- It was agreed to await further quotes before deciding whether to repair or replace the roundabout.

# **1366.** Reports from County and District Councillors

# Cllr Ray Gooding (RG).

AD asked RG if he could arrange for Highways to carry out a traffic count on Birchanger Lane.

The Local Highways Panel is currently suspended. There is therefore a hold on most applications although some small applications may proceed. It can take up to 3 years for application approval, and the County Council will probably not exist then (due to the planned changes). The new administration would not be held to any decision made by the current Local Highways Board.

A new "U" turn sign has been requested for installation at the junction of Birchanger Lane and the A120.

RG has reported the problem with the drains just before Tot Lane in Birchanger Lane.
