1078. Chairman's Welcome

The Chairman welcomed all those present.

1082. Minutes of the last meeting

The minutes of the last meeting held on Tuesday 4th April 2023 had been previously circulated. The minutes were agreed as a true and accurate record and were duly signed by the Chair.

1083. Planning

UTT/23/0948/HHF – 3 Hillside End, Birchanger Lane

Demolition of existing veranda and conservatory. Construction of single storey flat-roofed rear/side extension.

No objections.

Wren's application for distribution centre at Great Hallingbury.

The Parish Council agreed to support Great Hallingbury's comments on the proposed development.

1084. Traveller's encampment update

The correspondence between Uttlesford Planning and the Birchanger Residents Association had been circulated. The Planning Committee is due to consider the latest application on 7th June.

1085. A120/M11 roadworks

AD, GD, ST and GT attended the presentation hosted by SISK, who are the contractors.

Birchanger Lane should be open by the end of May/beginning of June and the traffic lights removed from the A120. However, residents of Birchanger will only be able to turn left at the junction of Birchanger Lane and the A120 until completion of the works at the roundabout and commissioning of the traffic lights. The contractors were asked if temporary traffic lights could be installed at this point to assist motorists from Birchanger Lane joining the A120 traffic. Initially this was turned down but Highways have been asked to look again at the request. Their response is awaited.

There is a proposal to close the bottom end of Birchanger Lane for remedial drainage work. AD queried this with Essex Highways and SISK. RG is to follow this up with Highways Officers to see if this can be delayed at least until the top end of the Lane is open.

1086. Allotments/Recreation Ground

Allotments – There are currently four vacant plots. One person is interested in taking on a plot. The clearance of recently vacated plots is awaited.

LP said that she would like to proceed with trimming of the overhanging oak tree. It was agreed that as this is bird nesting season this should be delayed to later in the year. LP will contact Ace of Spades to arrange for them to carry out the work at a suitable time.

Recreation Ground – GT has circulated details of possible replacement picnic tables. The options are for metal tables costing approximately £1000 or recycled wood/plastic tables at £400-£600. GT will continue to investigate.

Consideration needs to be made for wheelchair access.

GT will continue to look for play equipment replacements.

HAGS have quoted an amount of £2165 to fully renovate the zip wire, and have recommended that a full inspection be carried out each year. It was agreed to proceed with the renovation.

1087. Renewal of Parish Council insurance policy

It was agreed to proceed with renewal of the existing policy at the quoted premium of £1995.01.
